Through targeted programs providing housing, vehicles, counseling, and confidential peer support, the organization addresses ongoing emotional, practical, and financial challenges beyond legal proceedings.

Stand in the Gap Foundation's primary program service is providing direct financial assistance, housing support, vehicles, counseling, and confidential peer support to former January 6 defendants. In 2025 the organization distributed \$380,000 in grants and direct aid to help individuals overcome trauma, rebuild relationships, and restore their futures beyond legal proceedings. This is the organization's largest program by expense.
